### **Budget Update**

Additionally, Art reviewed how Chimacum School District fits into this report.

Art Clarke discussed the State Auditor's report on comparing the financial picture of Chimacum School District with other districts of like size. The State Auditor's Office will continue to monitor the financial health of the district.

Currently the district's fund balance is below the Board's goal of a 5% minimum fund balance.
